Showing the Owners/Occupiers of pews in Holy Trinity Parish Church, Sutton Coldfield


On Heritage Open Day 2019, there was a display in Holy Trinity Parish Church relating to the so-called "Box Pew Rumpus" which took place there in the 1760s. A review of that display can be seen in the *Galleries* section of our website (www.sclhrg.org.uk) entitled "Holy Trinity Parish Church Heritage Open Day 2019".


If you owned a house in Sutton Coldfield in the 18th century, it entitled you to a specific pew in the church. If you sold your house, you gave up that pew. However, a major upset occurred in 1762 when new pews were installed in the Church by the Corporation. It was their right to decide on the arrangement of the seating. However, unauthorised people began to claim some of the seats and old parishioners, who had occupied pews for many years, complained about the position of their new ones. This led to many disgruntled people in the congregation taking steps to redress the situation – hence the "Box Pew Rumpus".

A plan by William Hiorns was drawn up in 1762 to show the new allocation and, as promised in the review of the display, a copy of that plan is now included herewith, together with a Transcription of it showing a list of the owners/occupiers of the pews. As many of the residents of the town are named, this list can be a very useful record for people researching the history of Sutton Coldfield.




